MODE OF MEETING

ENTITLEMENT TO PARTICIPATE AND APPOINTMENT OF PROXY OR ATTORNEY OR CORPORATE REPRESENTATIVE

- Only members whose names appear on the Record of Depositors ("ROD") as at 15 November 2024 shall be entitled to attend, speak (in the form of real time submission of typed texts) and vote in the 12th AGM or appoint a proxy(ies)/ corporate representative(s)/attorney(s) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- In view that the 12th AGM will be conducted on a fully virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the 12th AGM yourself, please do not submit any Form of Proxy for the 12th AGM. You will not be allowed to participate in the 12th AGM together with a proxy appointed by you.

II. Steps for Corporation or Institutional Shareholders

- Complete the registration form and upload the required documents.
- Registration will be verified, and you will be notified by email within one
 (1) to two (2) working days.
- Proceed to activate your account with the temporary password given in the email and re-set your own password.

Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. - Print the confirmation report of your submission for your record.

VOTING AT MEETING

- The voting at the 12th AGM will be conducted on a poll pursuant to Paragraph 8.29A of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad ("Bursa Malaysia"). The Company has appointed Tricor to conduct the poll voting and Coopers Professional Scrutineers Sdn. Bhd. as Independent Scrutineers to verify the poll results.
- Shareholders or proxy(ies) or corporate representative(s) or attorney(s) can proceed to vote on the resolutions before the end of the voting session which will be announced by the Chairman of the Meeting and submit your votes at any time from the commencement of the 12th AGM at 10.30 a.m. Kindly refer to "Procedures for RPV" provided above for guidance on how to vote remotely via TIIH Online website at https://tiih.online.
- Upon completion of the voting session for 12th AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
